Birth of the Society

In August 1976, Imogene Kennedy obtained permission from Hank Blasik, Director of Montgomery County's Library system, to hold a public meeting to consider forming a genealogical society in Montgomery County. About fifty persons attended. George M. Hope was elected president, and the Montgomery County Genealogical Society was born. By the end of the first year, membership stood at ninety-two.

Society Contributes to the Genealogy Department of the Library

At the time that the Society was formed, the genealogical section of the county library had only six books. In an effort to contribute to the fledgling growth of the genealogy department and in keeping with its stated purpose, the Society quickly began to collect and publish Montgomery County's historical records. Over the last forty one (41) years (August 1976 – February 2017), the genealogical section of the county's library has arguably become the third largest and best equipped genealogical library in Texas.

Society Business Offices

The Society has conducted its business affairs from four different locations from 1976 till 2016.

The first office was within the old Conroe National Bank building basement from 1977 till 1998 when the building as sold to Walgreens and a new pharmacy constructed. Again, we thank Oliver Kniesly (posthumously) for his generous donation of letting the Society conduct its business affairs there for over 21 years.

From 1995 till 2001, the Society conducted its business affairs from an area office located adjacent to the genealogy department. Due to ever increasing size of the library, we lost our space but we thank Ms. Jerilynn Willems for the time we were allowed to meet here.

In 2001 the Society again relocated its business office. This time to a office space on Thompson Street adjacent to the old J C Penny building in Conroe. That gift of space lasted until 2010.

In 2010, a request was made to the Commissioners Court requesting a meeting space. It was considered to in the Library Systems best interest, so the County offered the Society two rooms at its newly acquired property at 1500 North Frazier St in Conroe. As of this writing February 2017, we are still here.
